## ORDER

The Lt. Governor, Delhi is pleased to constitute with immediate effect, a District Task Force for each district with the following composition:

- 1. Concerned District Magistrate/ Deputy Commissioner Chairman
- 2. DCP of the District Member
- 3. Regional representative of the major land owning agencies-
  - (a) D.D.A. An officer not below the rank of Deputy Director/ Executive Engineer.
  - (b) M.C.D. Dy. Commissioner concerned
  - (c) P.W.D. A representative not below the rank of Executive Engineer.
- 4. Representative of other land owning agencies to be inducted wherever necessary.
- 5. Representative of Land and Development Office not below rank of Executive Engineer

The District Task Force shall perform the following functions:-

- (i) Act on information, source intelligence, complaints and reference from land owning agency/local bodies regarding encroachment on public land and construction of building without sanctioned building Plan.
- (ii) Direct land owning agencies to protect and recover encroached Govt. lands in Gram Sabha Land.
- (iii) Shall offer a plat-form for coordinating the action of different agencies including Police for effective action against encroachment on public land and construction of buildings without any building Plan and may issue such directions, as may be necessary in the circumstances to any private or public authority to achieve said purpose.
- (iv) Shall be empowered to recommend any disciplinary action against officials of any land owning agency, Police or Public Authority for its failure to carry out the directions of the District Task Force.
- (v) Shall have jurisdiction over all land owning agencies, local authorities, Police and any other Public authorities falling in the jurisdiction of the relevant district in the matter related to unauthorized construction and encroachment over public / government land.
- (vi) Shall meet on fortnightly intervals or more often, as may be required, to dispose off the matters brought before it.
- (vii) Shall be empowered to issue directions to various land owning agencies and local bodies to protect and maintain the Govt. land including Gram Sabha land and for initiating action against buildings without sanctioned building plans.
- (viii) The meeting of the District Task Force shall be attended by the concerned Members in person and no substitution shall be allowed. In case, the concerned Member is unavailable due to unavoidable circumstances, prior leave or absence may be taken from the Chairman, District Task Force.

- (ix) Regular monthly report shall be submitted by the District Task Force to the Chief Secretary through Pr. Secretary (Rev.)/Divisional Commissioner by 7<sup>th</sup> of every succeeding month.
- (x) District Task Force may issue any such direction, as it may deem fit, to effectively regulate the functioning of the District Task Force so that effective action is taken against encroachment of Govt. land and construction of building without sanctioned building Plan.

This order shall supersede order No. F.13(32)/92/LSG/UD/17021 dated 15.12.1995 and modified order of even number dated 31.12.1995 & 08.08.1996, No.F.27/SDM/KJ/2010/96 dated30/3/2011.
