- III.** The objects for which the Company is established are:-


A. THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ARE:—

1. To Carry on in India or elsewhere the business of development of Computer Software for export and domestic market via magnetic tape satellite link Internet e-mail, or by any other mode of communication and transmission of software now available or developed in future and to carry on activity in trading, marketing, distributing of all and every type of computer software packages or computer programme by any mode and in particular through Internet.
2. To carry on the business of designing, developing, installing, implementing and operating all kinds of software/information technology projects and rendering technical services, business transformation projects and assistance for start-up, commencement and expansion programme and to act as technical and software development in India and abroad.
3. To carry on the business as designers, developers, buyers, sellers, importers, exporters and dealers in all kinds of computer software, computer technology and information technology products including cloud hosted business platforms and computer application products, systems, peripherals and materials, and to undertake the business of system and network integration and development, product application and development, computer maintenance and technical support services, internet access, networking and electronic media, telecommunication and web commerce application services.
4. To develop, maintain and best web site and other data on the Internet or on any other public or private network existing or that may be developed in future and to act as Digital Signature Certifying Authority or any other public or private network existing or that may be developed in future.
5. To develop, implement, convert, export, import, distribute, sell, buy, alter, exchange, maintain, let on hire or otherwise, deal in computer software and hardware, firm ware and in electronic, electrical, electro-mechanical and other similar equipment.

6. To establish and operate data and information processing centres and business to render service to customer in India and elsewhere by processing their jobs as data processing centres and giving out computer machine time on hire or license basis.

3. To establish, provide maintain and conduct or otherwise subsidise research laboratories and experimental works for scientific and technical research, experiments and to undertake and carry on all scientific & technical research, experiments and test of all kinds and to promote studies and research both scientific and technical investigation and invention by providing subsidising, endowing or assisting laboratories, workshops, libraries, lectures, meeting and conferences and by providing the remuneration to scientific and technical professors and teachers and to award, scholarships, prizes, grants and bursaries to students and to encourage, promote and reward studies, researches, investigations, experiments, tests and inventions of any kind that may be considered likely to assist the main business of the company.

To acquire by concessions, grants, purchase, license or otherwise either absolutely or conditionally and either alone or jointly with others land, building, machinery, plants, utensils work, conveniences and such other movable and immovable properties of any description and any patent, trademarks, concessions, privileges, brevets d'inventions, license, protection and concessions conferring any exclusion or limited rights to any inventions, information which may seem necessary for any of the objects of the company and to construct, maintain and alter any building or work, necessary or convenient for the business of the company and to pay for such

9. To purchase or otherwise acquire and undertake the whole or any part of the business, property, rights and liabilities of any company, firms or person carrying on business which this company is authorised to carry on or is possessed of rights suitable for the main objects of this company.
10. 12. To open accounts with any banks or financial institutions and to draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, hundis, bills of lading, warrants, debentures and such other negotiable or transferable instruments of all types and to buy the same.
13. Subjects to section 73, 74, 179, 181, 185 and 2 of the Companies Act, 2013 and the Regulations made therein and the directions issued by Reserve Bank of India, to borrow, raise or secure the payment of money or to receive money as loan, at interest for any of the objects of the company and at such time or times as may be expedient by promissory notes, bills of exchange, hundis, bills of lading, warrants or such other negotiable instruments of all types or by taking credit in or opening current accounts or over-draft accounts with any person, firm, bank or company and whether with or without any security or by such other means, as may deem expedient and in particular by the issue of debenture or debentures stock, perpetual or otherwise and in security for any such money borrowed, raised or received and of any such debentures or debenture stock so issued, to mortgage, pledge, or charge the whole or any part of the property and assets of the Company both present and future, including its uncalled capital, by special assignment or otherwise or to transfer or convey the same absolutely or in trust and to give the lenders powers of sale and other powers as may seem expedient and to purchase, redeem or pay off such securities, provided that the Company shall not carry on the business of banking within the meaning of the Banking Regulation Act, 1949.
14. Subject to Section 180, 184, 185 & 186 of the Companies Act, 2013 and Regulations made there under and the directions issued by RBI, to receive, raise or borrow any sum or loan upon such terms & conditions, in all respects as they may deem fit and to hold in any form, advance and negotiate loans on moveable or immoveable property, with or without security whether guaranteed or not, to such persons, firms, institutions or body corporates, upon such terms & conditions as the Company may deem fit. To include borrowing from any government agencies/authorities/organisations as required at times but within the purview of this clause.
15. Subjects to the provisions of sections 67 of the Companies Act, 2013 to invest other than investment in company's own shares and deal with moneys of the Company not immediately required in such shares or upon securities or investments and such manner as may from time to time, be determined.
16. To delegate powers: Subject to Section 109 of the Companies Act, 2013, from time to time and at any time to delegate to any persons so appointed, any of the powers, authorities and discretions for the time being vested in the Board, other than their power to make call or to make loans or borrow moneys, and any such appointment or delegation may be made on such terms, and subject to such conditions as the Board may think fit, and the Board may at any time remove any persons so appointed and may annul any such delegation.

17.
